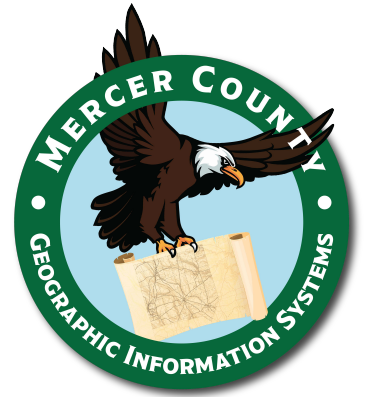

1. The following terms & conditions of this agreement shall be applicable to all geospatial datasets provided by Mercer County ("the County") to the end user ("customer") & shall govern the use of such datasets.
2. This agreement hereby granted unto the customer authorizes the use of geospatial data only for the purposes of making personal, or in the case of business, internal use of the licensed data as follows:
  - a. The geospatial data, provided to the customer, **shall not** be reformatted, copied, or further reproduced or distributed to any person, firm, corporation, association, or entity (this includes publishing data provided to on-line data repositories, data clearinghouses, or web gis platforms). It is the responsibility of the customer to maintain the data once transmitted, and to ensure that the copy provided does not become lost, corrupted, damaged or deprecated.

## Terms & Conditions (continued):

3. The customer acknowledges and accepts the Mercer County GIS Disclaimer, furthermore, the customer waives any rights to claim for damages incidental, consequential or special, arising out of or in connection with the use or performance of data provided. Lastly, the customer shall indemnify the County, the elected officials of the County, and the staff of the County from any and all liability or damages in relation to the use of geospatial data provided.
4. All geospatial data shall be provided in a file geodatabase format, and shall be transmitted to the customer via email or a dropbox link, unless requested otherwise. Additional costs may arise for alternative data formats and alternative methods of transmittance.
5. Some geospatial data, authored and maintained by the County is available for download, free of charge, at the Pennsylvania Spatial Data Access (<https://www.pasda.psu.edu/>). However, it is the responsibility of the customer to determine if the geospatial data available from PASDA shall fit their needs. Furthermore, it is ***not*** the responsibility of the County to advise customers of available data on PASDA or to determine if it shall fit the needs of the customer. Please note that the data available on PASDA is updated often but has many fields redacted.
