## APPROVAL OF MINUTES FROM THE 08/13/14 MEETING AS PRESENTED

#### TREASURER'S REPORT

Beg Bal.: \$6299.54. Expenses: \$4012.00. Balance as of 8/31/14: \$2287.54.

### **ENGINEER'S REPORT**

- 1. **Grinder Pump Maintenance Agreements** Were due back on 7/31/14. The final notice was sent on 8/13/14 to those residents who have not turned theirs in yet. The number outstanding as of today is below 40. Dan would like to discuss sending a final follow-up letter in October, before we advertise for grinder pump bids.
- 2. **List of Easements** All have been prepared and sent out except for a couple not completed yet.
- 3. Plantation Park Dan and Pat met with the Board of Directors. Meeting went well. They want to see the easement paperwork and then turn it over to their attorney.

- 4. **Building Permit for Plant** Permit is complete and Dan has possession of it. Dan will send a letter to the East. Lack. Zoning Hearing Board requesting the fee be returned since the lot size changed we no longer need a variance hearing.
- 5. **Revised Subdivision Plan for the Treatment Plant & Interchange Pump Station** Sent to the County Solicitor 8/21/14. It showed the additional easement required by Penn Power. Dan has not heard back from Penn Power on how they plan to supply electric to those facilities yet.
- 6. **Highway Occupancy Permit** Submitted to PennDot 8/1/14. Comments were received back on 8/28/14. Time was spent in the field addressing those comments. This will be re-submitted by the end of the month.
- 7. **Road Occupancy Permits** Issued by Findley Township on 8/6/14 and East Lackawannock Township 8/12/14.
- 8. Two or three people are thinking of building homes are interested in grinder pump agreements.
- 9. There are two right-of-way exhibits still not complete. (School & Brandy Springs Park).
- 10. **Amendment No. 2 to the Engineering Services Agreement** The cost not-to-exceed budget for the wetlands delineation, geotechnical investigation and rights-of-way preparation, referred to as Additional Services, were to be performed on an hourly basis with a budget of \$55,000. We are respectfully requesting an amendment to the Engineering Services Agreement for an additional \$19,000 for the engineering services associated with the rights-of-way and land acquisition portion of the project.
- \*A motion was made by John Lechner and seconded by Pat Suhrie to approve Amendment No. 2 to the Engineering Services Agreement. Motion carried.
