Plantation Park – Their edu's have dropped, through February their average was 58.

**PSP Barracks** – Dan still has not heard from them about the schedule for the sewer line for the construction cost estimates so they can prepare the developers agreement. The gas line has been installed. The gas company has been known to use all of the space in the right of way so Dan is going to monitor this.

NPDES Permit Renewal – This was submitted to PA DEP on 2/26/2024. This is a (5) year permit

# **OPERATORS REPORT**

The plant performed within the required parameters in January/2024.

Sludge was removed in January.

There was one grinder pump that was repaired.

## **OLD BUSINESS**

## **NEW BUSINESS**

**Sewer Extension** – Dan is looking into the cost of a sewer extension to the Iron Bridge Inn and to compare that to what it would be to replace their sewer treatment plant. He will be working on this over the next several months. Dan said PA DEP is giving them an ultimatum either fix the system with a major overhaul at their plant or connect to public sewer lines. Their permit goes until 2027. Dave Swartz brought up a question of would they pick up other homes/businesses along the way or just the Iron Bridge? Dan stated that if the Iron Bridge extends their line to ours, and we have taken ownership, anyone within 150' of the sewer line would be a mandatory connection. PA DEP will not allow it to be private. Dave is going to contact Springfield Township and see what their thoughts are regarding this. Dan will speak to John (Owner of Iron Bridge) and also see what his thoughts are.

Countryside Nursing Home – The nursing home does not want to take over ownership of the grinder pumps. We can't force this. There was talk of sending them a letter but nothing confirmed at this point.
