WARNING - If you receive an absentee-mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day. However, if you surrender your absentee or mail-in ballot and envelope to the Judge of Elections to be voided, you can you a regular ballot.
