To vote for a person whose name is not on the ballot, you must blacken the oval ( ) completely to the left of the line provided, and write or print the name in the blank space provided for that purpose. 3. Mark the ballot with a blue, black, or blue-black pen. Your ballot will be counted by an optical scanner and if you use anything else it may not be readable by the scanner. 4. If you make a mistake, request a new ballot.

**WARNING** - If you receive a mail ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day. However, if you surrender your mail ballot and return envelope to the Judge of Elections to be voided, you can vote a regular ballot.

| <div>CHARTER AMENDMENT 4</div> <div>Shall Section 7.1(a) of the Town of Greenville's Home Rule Charter be amended to read as follows: "All contracts of the town involving sums in of the "Written/Telephonic Bid" amount applicable to "Boroughs and Incorporated Towns," contained in the Pennsylvania Department of Labor's annual "Consumer Price Index Adjustment of Base Amounts on Bids" for the current year, shall be in writing and shall be executed on Behalf of the town by the Mayor or, in the individual's absence, the Town Clerk. The Mayor shall also execute all contracts, regardless of amount, for the purchase, sale, leasing, or use of real estate. Unless otherwise provided by ordinance, the Manager shall execute contracts on behalf of the Town involving Sums of less than the aforementioned "Written/Telephonic Bid" amount made pursuant to budget or other prior authorization. Authorization for contracts for the construction of public capital improvements shall be given by ordinance.
