Mark the ballot with a blue, black, or blue-black pen. Your ballot will be counted by an optical scanner and if you use anything else it may not be readable by the scanner. 4. If you make a mistake, request a new ballot.

**WARNING** - If you receive a mail ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day. However, if you
