Official Notice of Election for Military and Overseas Voters 2023 Municipal Primary Election May 16, 2023

This is an official notice of an election to be conducted on May 16, 2023, in Mercer County Pennsylvania. You may register to vote and request an official absentee ballot by using the Federal Postcard Application (FPCA) available at www.vote.pa.gov or www.tvap.gov. You may apply for an absentee ballot by submitting your FPCA by e-mail to thall@mercercountypa.gov or by fax to 724-662-1530.

You may request an absentee ballot from this office at any time prior to a primary or election. If time does not permit you to receive and return an official absentee ballot, however, you are also entitled to vote using the Federal Write-in Absentee Ballot (FWAB). Military electors may also use the FWAB to register to vote and vote simultaneously.

If you requested a ballot using the FPCA You may use the Federal Write-in Absentee Ballot (FWAB) to vote for all state and local offices and ballot questions. The Official Backup Ballot and instructions are on page 3 of the FWAB.

To vote for state and local offices or for ballot questions, write the names of candidates or ballot initiatives in the Addendum Section of the FWAB. Under the Office/Ballot Initiative heading, enter the office the candidate is running for or the title of the ballot initiative. Under the Candidate Name, Party Affiliation, or Initiative Vote heading, list the name of the candidate you wish to vote for or if you are voting on a ballot question write "Yes" or "No".

Mercer County will have primary ballots for Democrats, Republicans, and for Unaffiliated Voters in certain municipalities. Democrats and Republicans can vote in all state, county, school district, and municipal contests. Unaffiliated voters can only vote on local questions that may be on the ballot.

The Municipal Primary Election will be held in the ninety (90) voting districts of Mercer County on May 16, 2023. The polls will be open from 7:00 AM until 8:00 PM, prevailing time. If you submitted an FPCA, you must affirm that you mailed your ballot no later than 11:59 pm on May 15, 2023, and the County Election Office must receive your ballot no later than May 23, 2021, by 5 pm, prevailing time. Regular mail-in and absentee ballots submitted by voters must be received by the Board of Elections by 8:00 PM on May 16, 2023.
