Instructions for completing the Request for Appropriation from the Mercer County Unconventional Gas Well Fund (UGWF)

Individuals desiring to apply for a UGWF award can discuss their projects with the Mercer County Fiscal Office (724-662-3800 x 2541(Nicki)) who will verify that it meets the criteria or the intent of the award program. The Request for Appropriation form is a Word document with expanding fields.

- 1. Enter a project name that will identify the project for the duration of the award period.
- 2. Enter the date that the application is made.
- 3. Describe the location of the project. Include the municipality, address or property owner, and distance from the nearest landmark. Attach a map.
- 4. Enter the name of the applicant, sponsoring organization.
 - 1. Address of sponsoring organization
 - 2. Contact information: e-mail address, day-time phone number.
- 5. Enter the name of the project leader who will be the contact person for the duration of the project. Enter the contact information including a daytime phone number.
- 6. Mark the appropriate box/boxes that describe your project.
- 7. Describe your project in 1,000 characters or less (not including spaces).
- 8. Describe the public benefits you expect to gain from the completed project.
- 9. Describe the project timeline, including milestones and duration of project work
- 10. Enter the estimated cost of the project. Attach a detailed budget that describes costs for each phase of the project, the sources of funding that
- 11. includes UGWF amount requested and all other sources of funds.
- 12. Enter the amount of funds requested from the Mercer County Unconventional Gas Well Fund.
- 13. The application must be signed by an officer of the organization or authorized project leader.
- 14. Print the application to hard copy before submitting by (a)mail to Mercer County, Attn: Fiscal Office, 208 Courthouse, Mercer PA 16137, or (b) email to Nicki Biles nbiles@mercercountypa.gov. Supplemental attachments are welcome.
- 15. If funds are awarded, Awardee shall include in all public communications about this project: "Partial funding provided by Mercer County Commissioners from Unconventional Gas Well Impact Fees distributed under Pennsylvania Act 13 of 2012." Include this notice in news releases, fund-raising literature, notices to other sponsoring organizations, project signage if applicable, etc.
- 16. When the work is completed, please submit a closing report including photographs if possible.
