Controller Amundsen reported that implementation of the new software reporting system is progressing. It has been delayed due to COVID-19. The anticipated date for conversion may be year-end or early in 2021.

Commissioners expressed appreciation for the response to COVID-19. Many departments including Human Resources, the Public Safety Director, Maintenance and Custodial have responded to provide a safe, clean workplace and to communicate with staff, the public, state agencies and community partners.

The recently published April unemployment numbers are 15% for the State and 18% for Mercer County. With the County transitioning to Green Phase as of June 5th, the Commissioners anticipate some economic recovery.

Commissioners expressed sorrow over George Floyd's death and thanked everyone for their cooperation during public protests.

They also expressed thanks for the election process. Changes introduced with Act 77 were challenging and required more people, more time and more space. The Director of Elections appreciates having the necessary equipment to assist with handling the volume of mail-in ballots due to the legislative changes. He expects to complete the count and certify the election in a timely manner.
