General Discussion Items: See Below.

Erin Wells, Director of the Governor's Northwest Regional Office, presented remarks on behalf of the Governor. The Governor's Award Ceremony in Harrisburg was canceled due to COVID-19. She congratulated Mercer County for receiving the Local Government Excellence for Intergovernmental Cooperation Award. The Northwest and Southwest Behavior Health Management teams collaborated to reduce duplication of services, and costs while providing access to services for vulnerable populations.

Diane Helbig, from Senator Brooks' Office, presented a Citation to the Commissioners, MH/ID Director, Paulette Benegasi, and Mercer County Behavioral Health Commission Executive Director, Mary Ann Daniels, for the Nine (9) County project to address the backlog of released prisoners who need a better transition back into the community or help in finding long-term care facilities. Their hard work, vision and commitment is to be commended.

Commissioners noted that the Citation is very meaningful because Senator Brooks is a former Mercer County Commissioner and she understands the impact of local and regional collaboration to address Mental Health needs for the benefit of all residents.

Commissioners recognized that they submitted the application on behalf of the lead agencies efforts in the County and that this is the second consecutive year Mercer County has received the Intergovernmental Cooperation Award.

Commissioners commented on the CARES County Relief Block Grant. They highlighted two requests including \$10,000.00 from Greenville Reynolds Industrial Park for a plan to explore extending power in the Park so that other sites are "shovel ready" for development and \$20,000.00 for the Lawrence-Mercer County Recycling/Solid Waste Department to purchase a truck to coordinate volunteers for recycling events and litter cleanup projects.

Treasurer White and the Commissioners reminded the public that Doe License applications are currently available. The upcoming deadline for the first round of unsold Doe Licenses is August 3rd. Mercer County has been issued the same number of licenses as in 2019.
