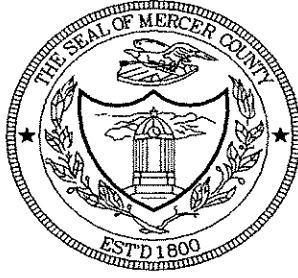

### **Approval of Minutes:**

President Pete Acker asks for a motion to approve the March 18<sup>th</sup>, 2025 Prison Board meeting minutes. Commissioner Ann Coleman makes the first motion and it was seconded by Secretary Judge Wallace. Voice vote was unanimous, motion carried.

### **Wardens Report:**

Warden McDuffie begins by stating that for the month of April there were 183 commitments, 188 releases and an average daily population of 213. He states that the jail's numbers have remained pretty consistent each month and does not have anything further to report at this time.

President Pete Acker asks for a motion to approve the Warden's Report. Commissioner Timothy McGonigle makes the first motion and it was seconded by Sheriff Callahan. Voice vote was unanimous, motion carried.

**IPP Report:**

IPP Director Tyler Shoaf begins by stating that for the month of April there were 73 referrals with 66 successful completions and 9 failures/revocations for a total of 608 clients. Savings to the county based on house arrest and Pre-Trial TASC had a total of \$130,000. Community service hours completed totaled 656 which had a savings to the work sites of \$4,758.

President Pete Acker asks for a motion to approve the IPP Report. Commissioner Coleman makes the first motion and it was seconded by Commissioner Finley. Voice vote was unanimous, motion carried.

**Committee Reports:**

None.

**New Business:**

Warden McDuffie informs the board that he has received reimbursement from the ACT 81 which is for the level four and five inmates on work release. He states that he will be forwarding the check over to Nicki in the Fiscal office.

**Old Business:**



**Vendor Requests:**

Warden McDuffie states that he needs 24 new radios. The older radios are getting broken down and many can no longer be used. The amount for the radios would be \$25,258 which would be paid through the canteen fund. Warden McDuffie asks the board for approval to recommend the purchase of the radios to the commissioners. Secretary Judge Wallace makes the first motion and it was seconded by Commissioner Finley. Voice vote was unanimous, motion carried.

President Pete Acker asks for a motion to adjourn. Secretary Judge Wallace makes the first motion and it was seconded by Controller Stephen Sherman. Voice vote was unanimous, motion carried.
